This announcement is a solicitation to determine those undergraduate members who are interested in running for the position of Undergraduate Director on the Grand Lodge and who will be in attendance at the 145th Anniversary Convention in Chicago, IL in August 2009. **Applications and most recent college/university transcript must be submitted to Fraternity Headquarters by July 7, 2009.**

Information on Positions:

1. According to the Constitution and By-Laws, candidates for the two Undergraduate Director positions must be undergraduate members and not enrolled in a graduate school program at the time of their election (Article 3.2.1).
2. Undergraduate Directors are elected in odd numbered years and hold office until their successors are elected (Article 3.2.2).
3. Nominations for Undergraduate Directors shall be made by interested members via a nominating petition that must be submitted to the Committee on Nominations at Fraternity Headquarters no later than 30 days prior to the National Convention (By-Law 20.7.2).
4. As a function of their jobs, one of the Undergraduate Directors shall serve on the Committee on Nominations (By-Law 22.3.1).
5. Each candidate for an Undergraduate Director Position must be in attendance at the National Convention in order to be eligible for election (By-Law 20.7.2).
